One (01) application of a private party in litigation, before the Juzgado de Primera Instancia de Cajatambo (*Court of First Instance corresponding to Cajatambo*), addressed by Luciano Eladir Pastrana as attorney in fact of Alfonsa Balabarca, in the lawsuit against Ascencia Figueroa, related to the notarization of the sale of the land "Tres Cruces". The folio is folded and the date and place are not visible, probably between 1868-1870. It has original foliation "24" in Arabic numerals and a green fiscal stamp at the top. The document is in a regular state of preservation, with worn edges and folds, which do not allow appreciating the binding marks, although it is assumed by the foliation that they belong to larger files. The handwriting is italic.

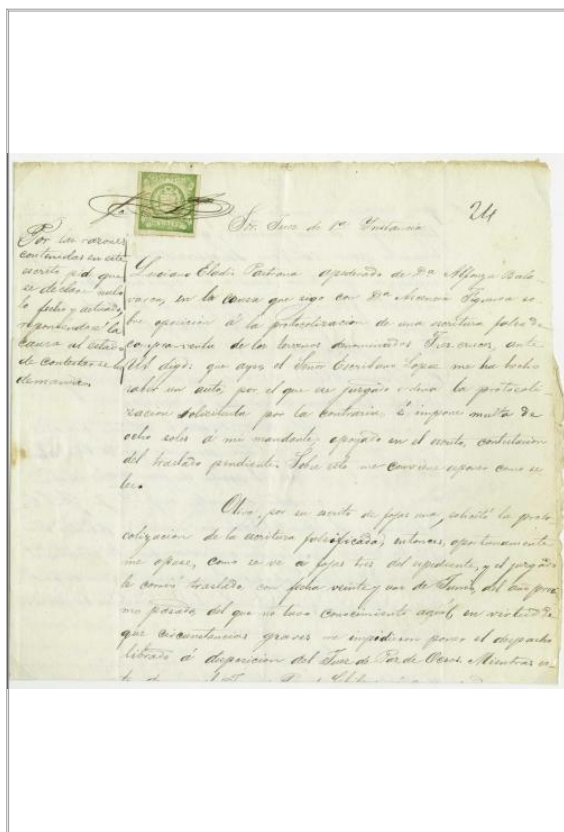

One (01) application of particular in litigation, before the Juzgado de Primera Instancia de Cajatambo (*Court of First Instance corresponding to Cajatambo*), directed by Mariano Diaz, subject to prison, in the criminal lawsuit followed by Antonio Padilla, priest of Marca, for robbery. The folio is folded, probably dated 14 October 1867. The folio has a red fiscal stamp and the foliation "39" in Arabic numerals. The document is in regular state of conservation, with worn edges and folds, which do not allow appreciating the marks of binding, although it is assumed by the foliation that they belong to larger files. The handwriting is italic.
